Considering how well Munday knew Oxford, it is important for the Shakespeare authorship controversy that, in his prefatory material, Munday mentions *both* Shakespeare and Oxford among the book's sources--Oxford among the nobility, Shakespeare among the actors. This may mean either that Shakespeare and Oxford were separate persons--the obvious Stratfordian conclusion--or that, by 1600, it pleased Oxford that they should be considered so-the obvious Oxfordian conclusion. Rather more interestingly, it militates against the extreme Oxfordian position that Shakespeare was an illiterate lout; Munday and/or Bodenham do give him authorial credit for something. (Because of the format of *Bel-vedére*, it's not possible to determine which similes and examples belong to which author.)
